

# PRIVACY POLICY

Feldstein Financial Group LLC (“FFG”) and Steven Feldstein & Associates (SF&A”) (collectively the “Company”) may obtain confidential information about you in the process account opening. At the Company, we understand that privacy is an important issue for our customers. It is our policy to respect the privacy of all information that we maintain and to protect the security and confidentiality of non-public personal information relating to those accounts. ## Personal Information Collected
